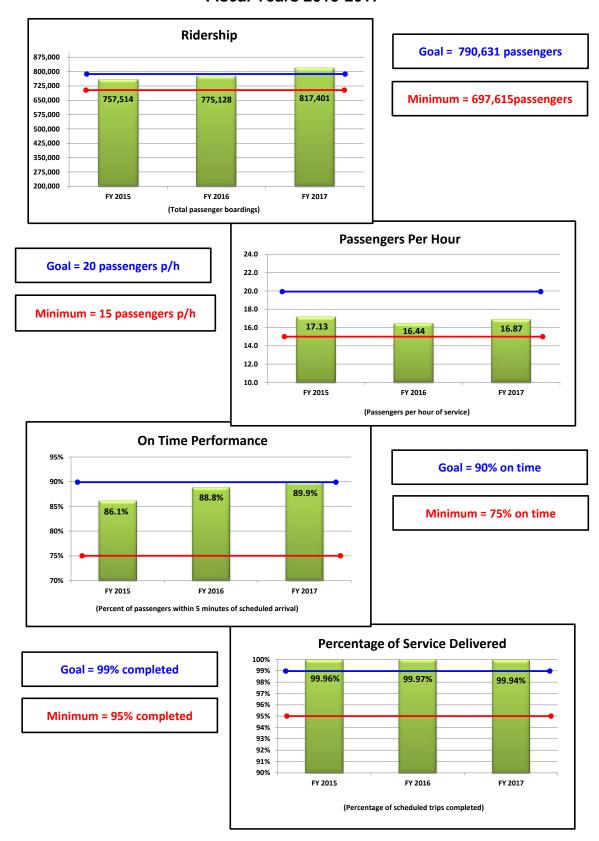

# MST Fixed Route YTD Dashboard Performance Comparative Statistics Months of July - August Fiscal Years 2015-2017

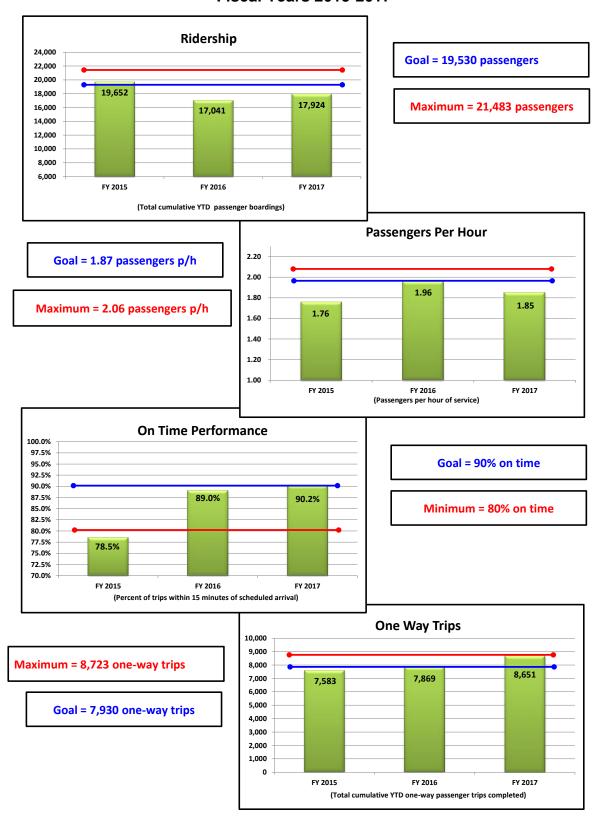

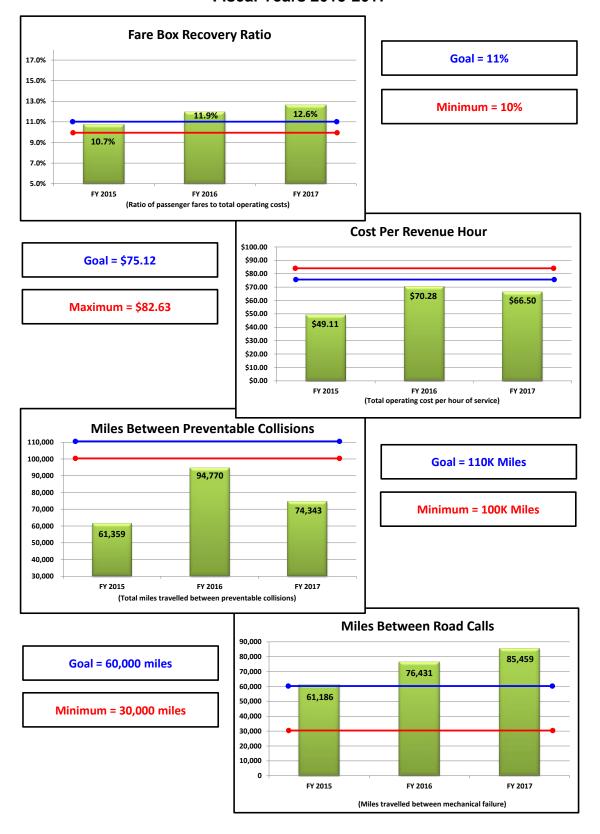

## YTD Dashboard Performance Comparative Statistics Months of July - August Fiscal Years 2015-2017



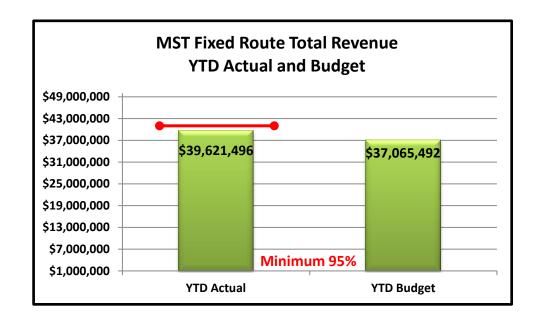

#### **FIXED ROUTE BUS OPERATIONS:**

#### System Wide Service: (Fixed Route & On Call Services):

Preliminary boarding statistics indicate that ridership increased by 6.36% in August 2016, (426,452), as compared to August 2015, (400,933). Fiscal year to date – passenger boardings have increased by 5.45% as compared to the same period last year.

Productivity increased from August of last year (16.6) to 17.1 passengers per hour for August of this year.

#### **Supplemental / Special Services:**

August 27-28: MST provided special shuttle services for the Annual West End Celebration in Sand City transporting 187 passengers during this two day event.

#### **System Wide Statistics:**

Ridership: 426,452

Vehicle Revenue Hours: 24,873Vehicle Revenue Miles: 398,098

System Productivity: 17.1 Passengers Per Vehicle Revenue Hour

One-Way Trips Provided: 35,063

**Time Point Adherence:** Of 132,425 total time-point crossings sampled for the month of August, the TransitMaster™ system recorded 20,467 delayed arrivals to MST's published time-points system-wide. This denotes that **84.45%** of all scheduled arrivals at published time-points were on time. (See MST Fixed-Route Bus ~~ On Time Compliance Chart **FY 2016**.)

Service arriving later than **5** minutes beyond the published time point is considered late. The on-time compliance chart, (attached), reflects system wide "on-time performance" as a percentage to the total number of reported time-point crossings.

Preliminary boarding statistics for the MST RIDES program reflect that for the month of August there were 10,616 passenger boardings. This denotes an 11.07% increase in passenger boardings from August of 2015, (9,558). Fiscal year to date – passenger boardings have increased by 5.56% as compared to the same period last year.

 Productivity for August of this year was at 1.87 passengers per hour decreasing from August of 2015, (1.96). • For the month of August, 89.68 % of all scheduled trips for the MST RIDES Program arrived on time, increasing from 88.45 % in August of 2015.

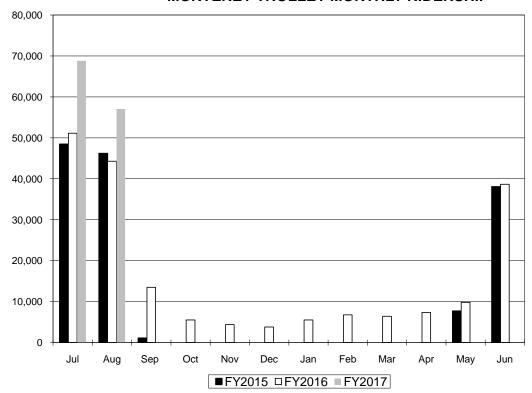

#### MONTEREY TROLLEY MONTHLY RIDERSHIP



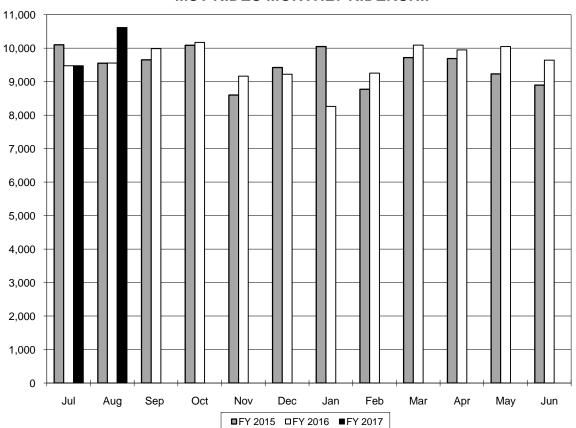

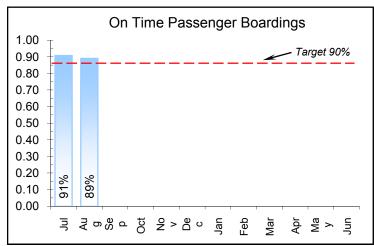

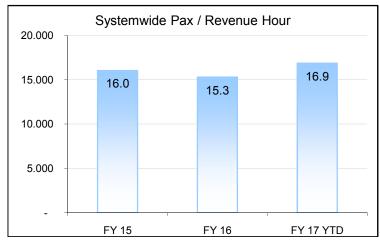

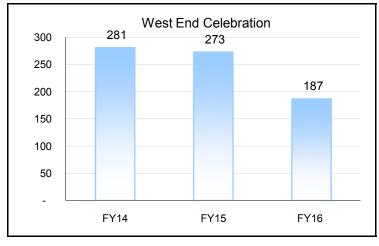

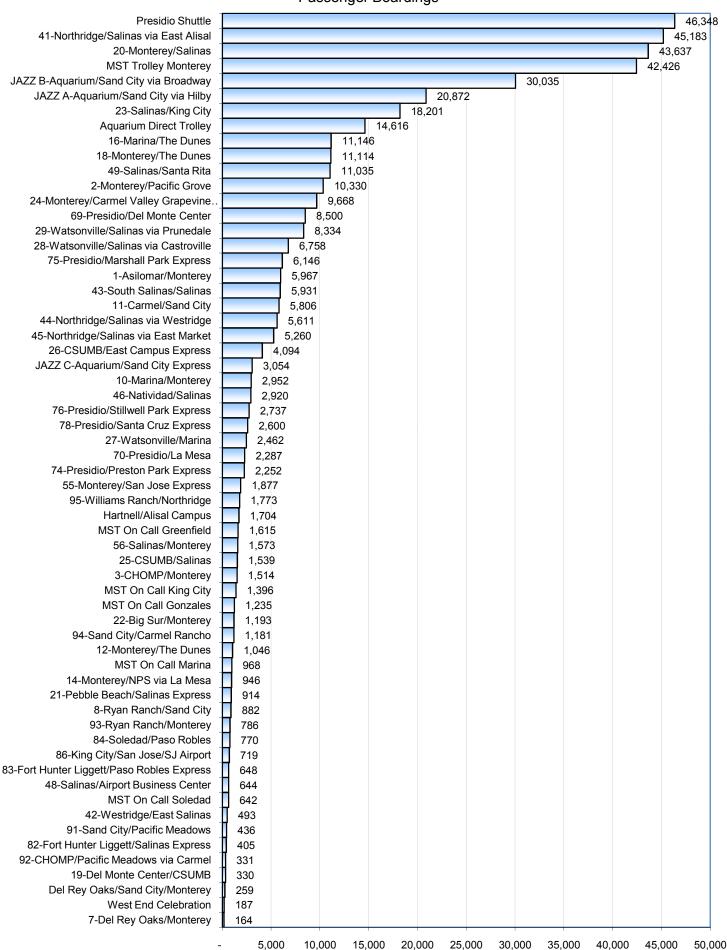




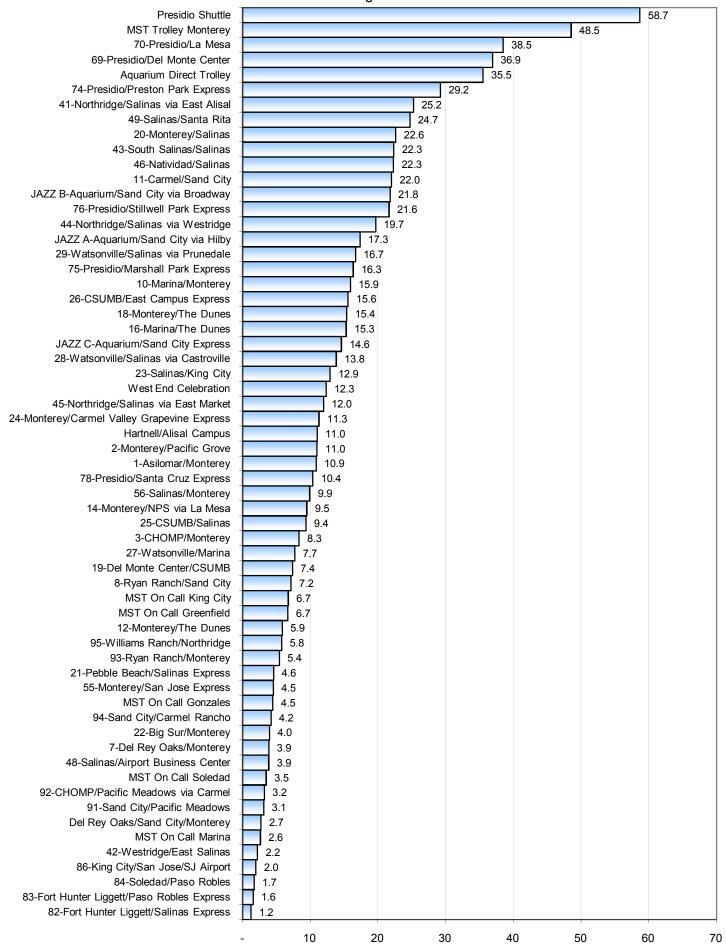




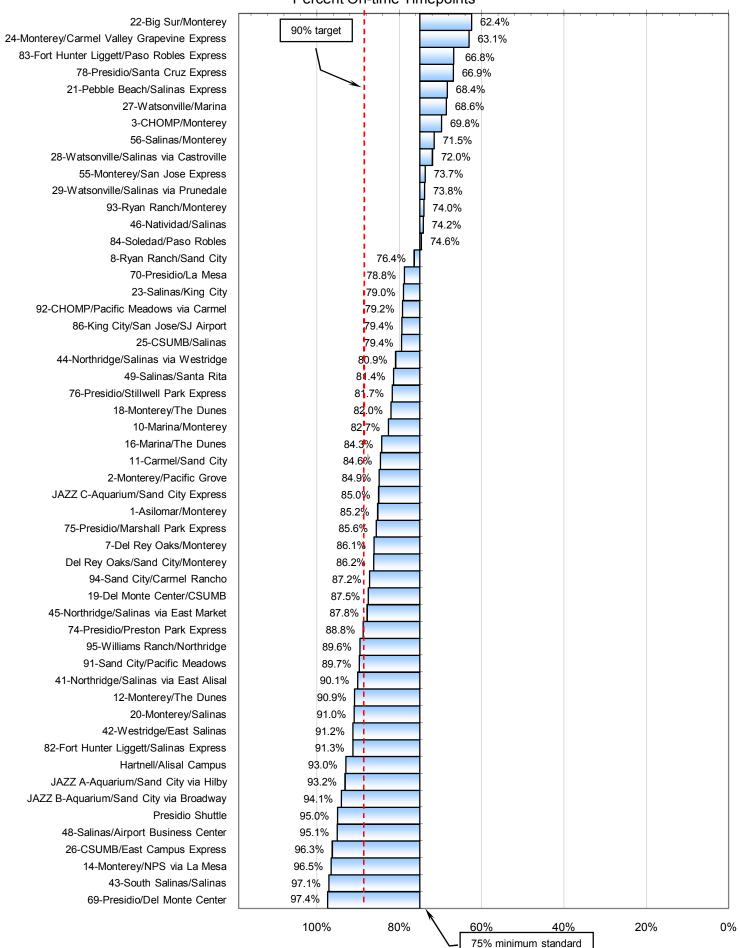
#### Ridership by Line - August 2016 Passenger Boardings

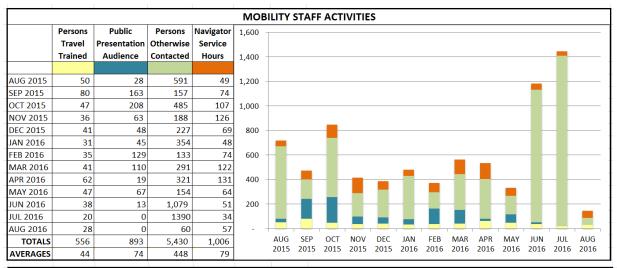
#### **Mobility Management Update - August 2016**

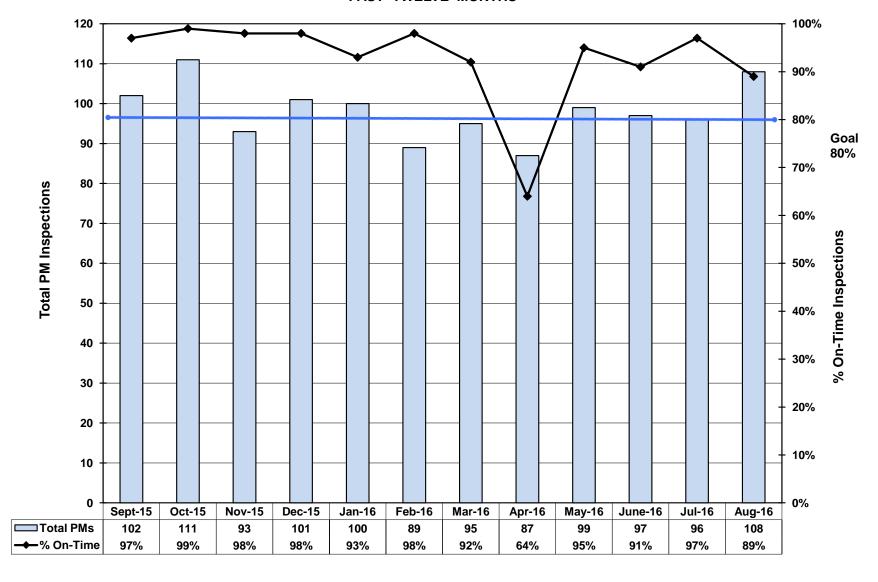
#### Miles Between Major Mechanical Roadcalls FY16 vs. FY17 YTD Year to Date Comparison

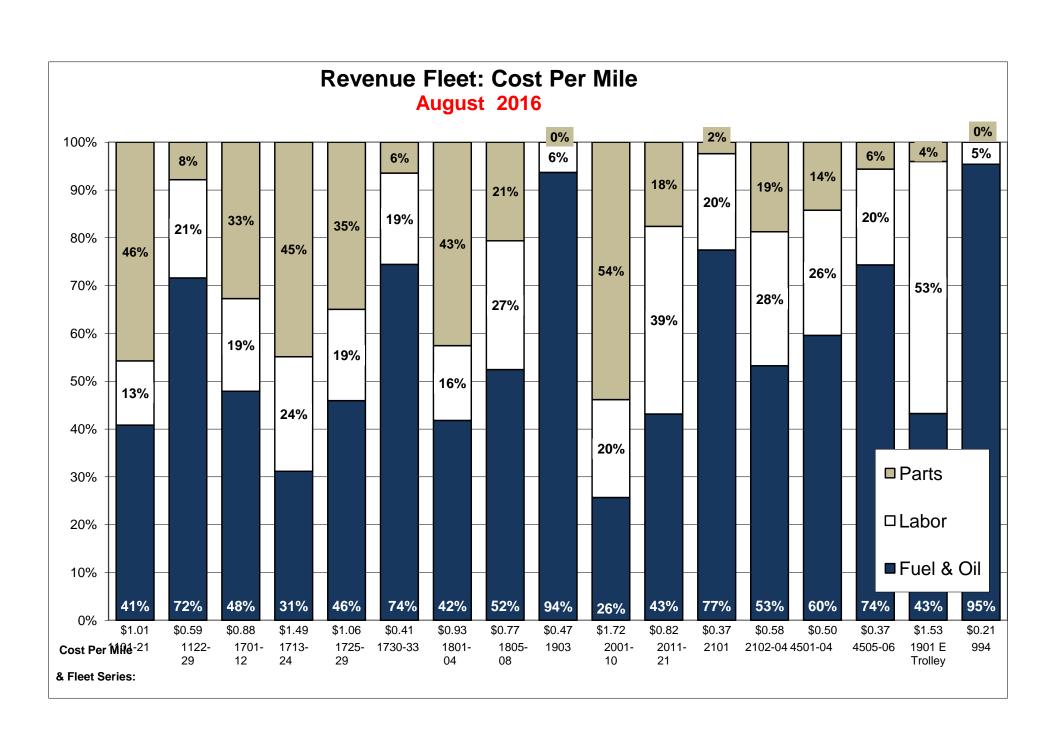


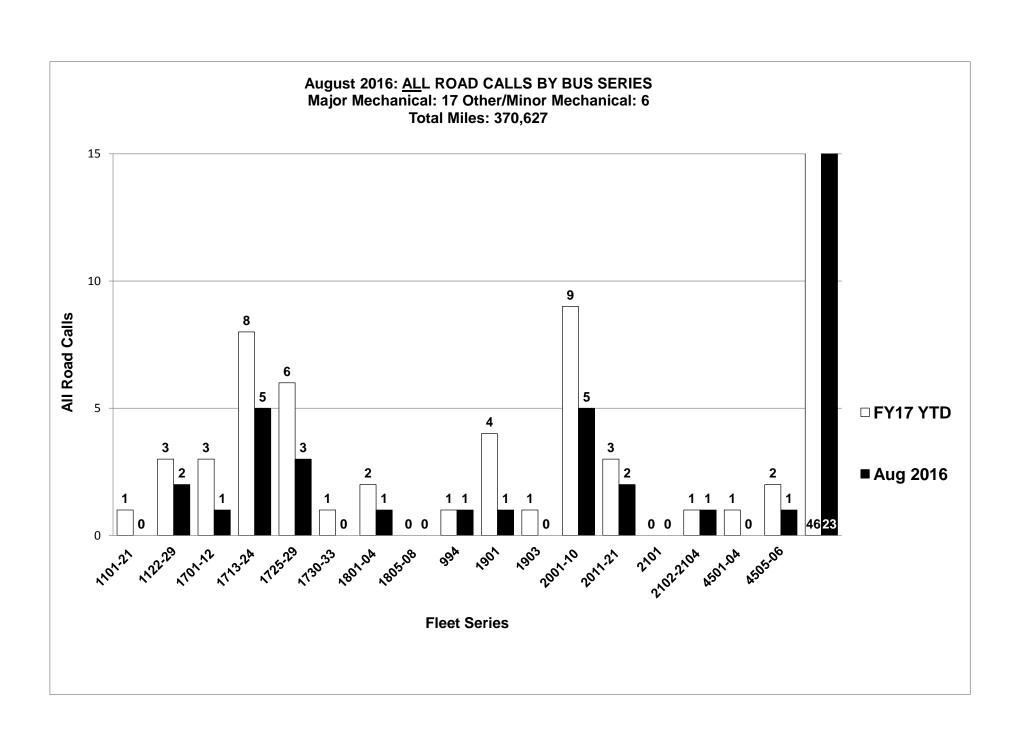


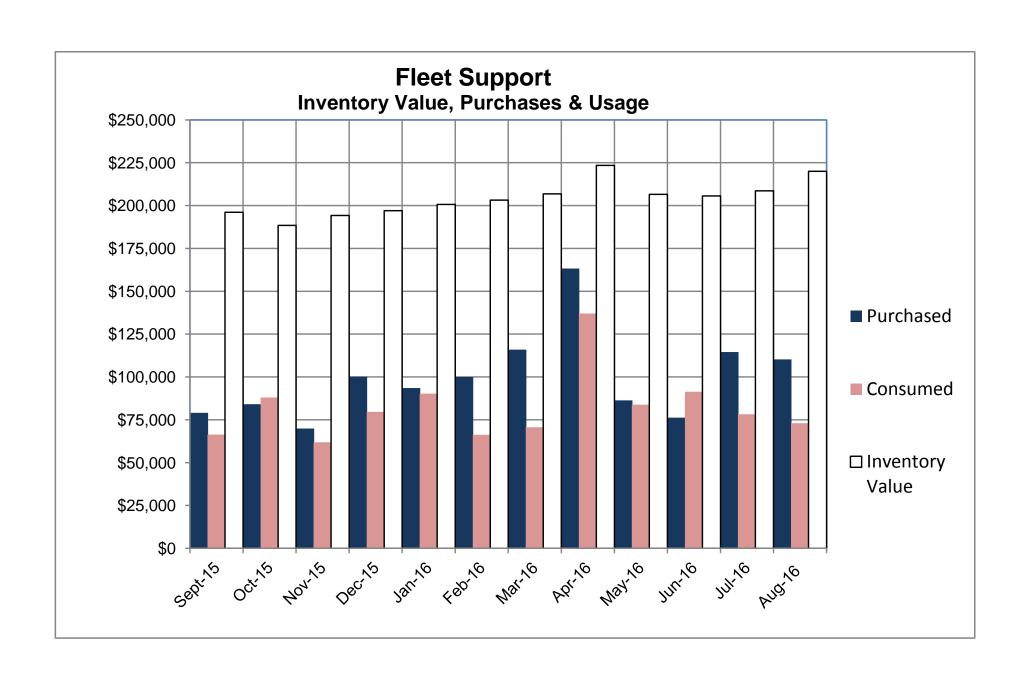

### PREVENTIVE MAINTENANCE (PMs) INSPECTIONS PAST TWELVE MONTHS





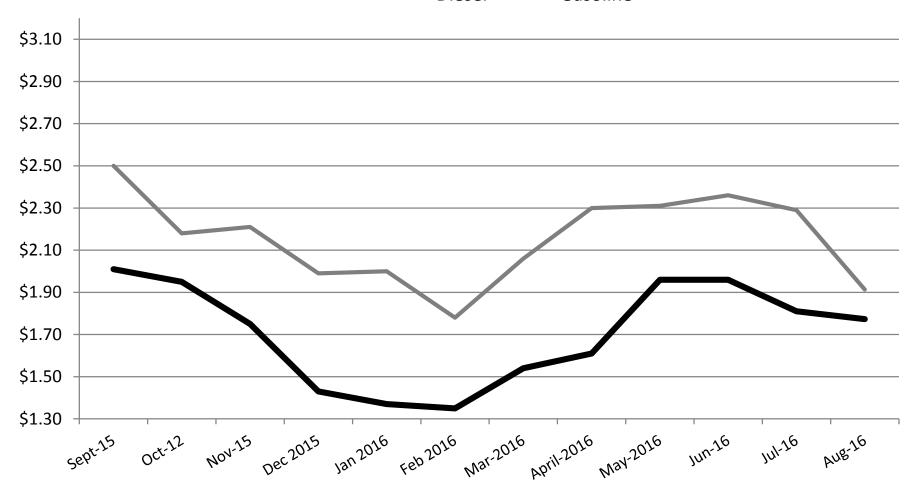




## **12 Month Rolling Fuel Cost**

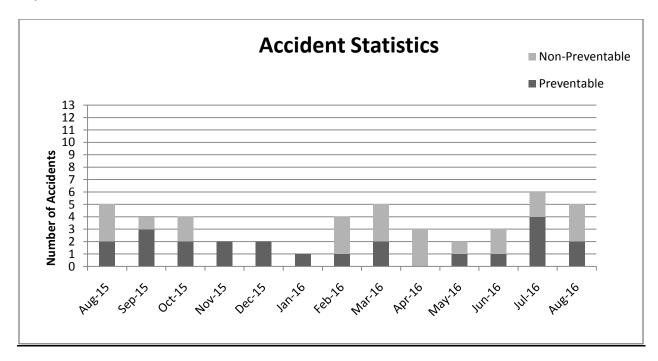

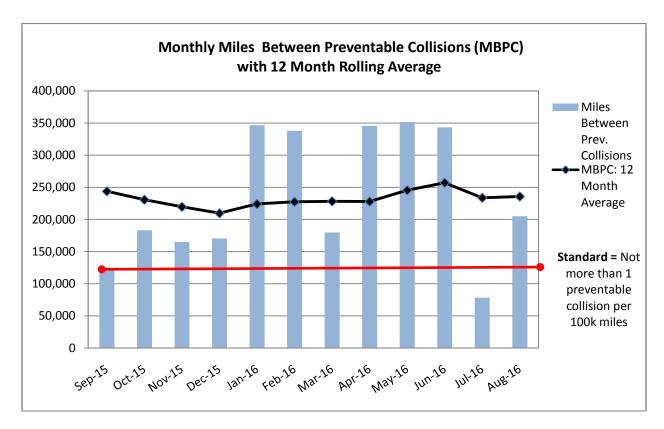

#### **Finance Update**

#### **General Accounting/Accounts Payable**

During the month of August, staff processed timely and accurate payments to vendors, recorded appropriate revenues, and prepared monthly financial reporting and analysis. Staff continues to work effectively to meet financial reporting deadlines.

In August, staff continued working on finalizing the annual audit preparation for FY16. Vavrinek, Trine, Day & Co. LLP (VTD) will perform the remainder of the audit during the week of September 26th.

#### **Payroll**

Routine changes and adjustments to payroll records were maintained along with filing of all federal, state, and retirement reports and payments on a timely basis. Payroll continued to provide hours and earnings reports upon request to MST departments

#### **Grants**

During the month of August, staff worked on a number of grant and compliance activities. Materials were prepared for the Fixed Facility Analysis for the South County maintenance facility. Reimbursement requests to Caltrans were prepared, and the semi-annual progress reports for Public Transportation Modernization, Improvement, and Service Enhancement (PTMISEA) funds were submitted on time.

Staff coordinated with TAMC and ITN Monterey County to compile all necessary information and documents to submit a grant application to the National Aging and

Disability Center. The final report for the Community Development Block Grant (CDBG) program was submitted on time.

#### <u>Purchasing</u>

During the month of August, parts staff was busy with managing inventory levels and ensuring continued supplies were available. Inventory levels are remaining under \$200K, and with new buses added to the fleet, parts staff is seeing a gradual decline in the expenditure of costly component replacements. Several large procurements were underway for Bus-on-Shoulder Consultant, and continued work on the MST Operations & Maintenance Facility, renovation, and expansion.

#### **Information Technology Update**

Staff monitored the hardware and software for the Trapeze Group TransitMaster (TM) Automatic Vehicle Location system. Staff monitored the Trapeze Enterprise Asset Management (EAM) vehicle maintenance system. Staff continued to support the users of the Serenic Navision accounting/payroll system. Staff monitored the functionality of the customer service database. Staff worked with Giro in continuing the Hastus system parallel testing.

Staff liaised with the County of Monterey Information Technology Department and Trapeze Group regarding the radio hardware to be installed to extend data/radio/cell coverage to include San Jose, Paso Robles, and other outlying areas of service. Staff monitored the virtual computer systems.

Staff worked with AT&T in continuing the transition to a Voice Over IP (VOIP) telephone system at all MST sites.

Staff continued to support other MST staff members as needed, proactively ensuring that all were supported fully with their IT needs.

#### **Planning Update**

During the month of August, staff continued to monitor the revenues and expenses for the military partnerships after implementation of the July 2014 Presidio reductions that were required because Congress allowed the expanded federal transit benefit to be reduced by nearly 50% effective December 2013. Revenues received from the federal transit benefit have stabilized and increased during recent months so that revenues are matching expenses and have fully made up for previous losses. During the month the Presidio, with assistance of MST Business Development Transit Planner, Mike Gallant, continued its targeted recruitment efforts to maximize military and civilian participation in the federal transit benefit program. This effort is intended to stabilize and

grow revenues for MST to continue operating the military-funded routes. Fortunately, Congress voted in December to raise the transit benefit again on a permanent basis. The benefit was raised for the Presidio participants on March 10, 2016. As such, staff will be meeting with the Presidio to re-evaluate the program with some expansions possible for the future.

Staff continued planning efforts with Camp Roberts in southern Monterey County with the goal of providing transit service after MST was awarded a FTA Section 5311(f) grant. As of Labor Day weekend, the new line 85 will provide military service members and the public with a bus route from Templeton to Fort Hunter Liggett with stops in Paso Robles and Camp Roberts.

Staff continued participation in coordination meetings with the City of Monterey as the Highway 68 Roundabout moved closer to construction. The project will impact traffic conditions throughout the area as well as MST routes serving the Monterey Peninsula.

Throughout the month, staff continued participating in meetings with various local agencies, including the Transportation Agency for Monterey County, Association of Monterey Bay Area Governments, Salinas Valley Chamber of Commerce Government Relations Committee, the Monterey County Hospitality Association, Monterey County Business Council, and the Fort Ord Reuse Authority.

The survey, conducted every two years since 2002, was released on Monday and presented to the MST board on July 11. The bilingual survey included 600 responses including with 26 percent of Spanish-speaking participants.

in all six categories, customer satisfaction saw an uptick.

- Driver safety rose from 88.7 percent in 2014 to 93.7 percent in 2016
- Bus cleanliness rose from 80.2 percent in 2014 to 85.4 percent in 2016
- Bus stops/amenities jumped from 70.6 percent in 2014 to 79.6 percent in 2016
- Friendliness/helpfulness of the driver jumped from 78.7% to 87.5%
- Friendliness/heipfulness of customer service rose from 73.7 percent to 81.3 percent

An estimated 4.5 million passenger trips are taken annually, which is the number of times someone boards a bus. The survey shows that people ride an average of two to three times a day.

Carl Sedoryk, General Manager and CEO of MST, said the number of riders continues to grow at 2 percent over the past four years.

Sedoryk attributes this to an "improving economy," including a growing number of people who are working in the tourism and hospitality industry in the Monterey Peninsula.

In recent years, MST has partnered with CSUMB, Hartneil College, the Defense Language Institute, Naval Postgraduate School, and military installations such as Fort Hunter Liggett.

Hotel occupancy rates in Monterey and ticket sales to key attractions such as the Monterey Bay Aquarium remain robust, said Sedoryk,

According to the Monterey County Convention & Visitors Bureau, tourism is the No. 2 industry for the county. It has created over 24,000 jobs and generates over \$2.7 billion in economic impact for the region.

"This has all generated increased ridership beyond normal worker commute," said Sedoryk.

Sedoryk said MST has worked to improve service, including investing hundreds of thousands of dollars (including from state grants) into new bus shelters.

Salinas City Councilmember Kimbley Craig said public transportation is critical to the city of Salinas.

"Building bigger roads isn't always the solution...Encouraging people to rideshare and use mass transportation is a solution," said Craig, noting the city has many working-class families many of whom work in hospitality in Monterey.

During harvest season there is also a 20% to 30% uptick in workers many who rely on public transportation, Craig said.

Ciclovía Salinas returns Oct. 9 for a fourth consecutive year of promoting human-fueled fun and mobility.

On that Sunday, 1.6 miles of East Alisal Street, from Main Street to North Sanborn Road, will close to cars and motorized vehicles. It opens exclusively to running, biking, skating, dancing, playing and other non-motorized recreation. Music, food and booths staffed by community service groups complete the festive lineup. Salinas boasts the only youth-led Ciclovía event in the United States. Each year, the Building Healthy

Communities chapter in Salinas assembles a panel of young people to organize the event.

Ciciovía is Spanish for "bike path." The first Ciciovia was held in Bogotá, Colombia in 1976. Bogota has closed miles of streets every Sunday for 40 years. Similar car-free street events have been replicated in cities across America and around the world.

Car-free streets can provide a safer environment in which families enjoy public space for recreational activity and physical exercise, and which helps prevent diabetes and obesity. Ciclovia Salinas is a sustainable event that promotes local businesses and fosters community-building.

The event will distribute free helmets to participants under age 18 to prevent injury and comply with the helmet law. Skateboarders and scooter users can also get helmets.

Bus pass discount: During construction on Highway 68 for the next few weeks, Monterey-Salinas Transit is offering a good discount on bus passes. Beginning Monday, its 31-Day Basic GoPass costs only \$13. The pass regularly costs \$95. Do the math, it's a real bargain.

Traffic delays that can fuel frustration, even road rage, among commuters and are expected during the months of construction on the Holman Highway 68 roundabout. By offering economical bus transit, MST officials hope people who do not usually ride the bus will give it a try to reduce traffic. Maybe some people will keep using the bus after construction is completed.

"It's our way of helping out the community, and especially hospitality workers, whose hotels, restaurants and shops will be located in the heart of the congested areas of the Peninsula," said Hunter Harvath, MST assistant general manager for finance.

The bus pass discount is available to those who live or work in these areas: Big Sur, Carmel, Carmel Valley, Pacific Grove, Pebble Beach and parts of Monterey. Salinas and south county residents who work in the affected areas must present a pay stub (or other proof of employment) to get the discount. The passes will be available Monday at MST transit centers. Monterey Peninsula Coilege students can get the discount on campus.

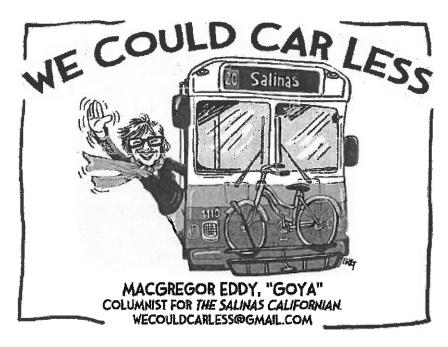
"The more people who ride the bus, the less traffic congestion will be an issue during construction," said Harvarth. "We'll be better able to keep the traffic flowing on local roads and provide... bus riders with the opportunity to save nearly \$1,000 over the duration of the construction period."

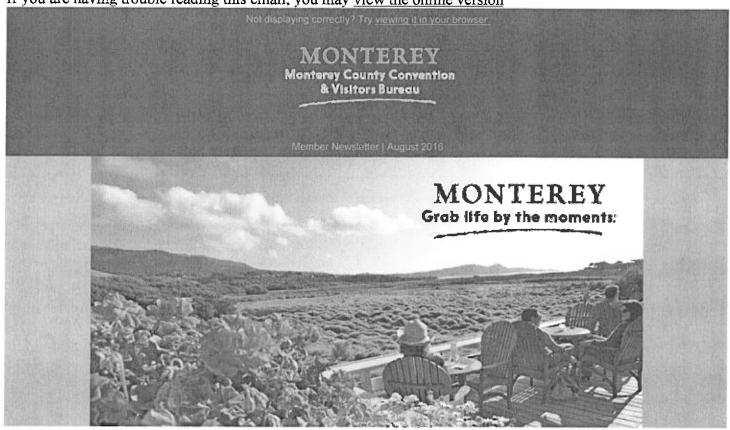

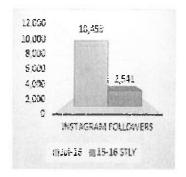

But this year, the end of Classic Car Week marks when work begins in earnest on the Holman Highway Roundabout project.

Day and night median barrier work, paving and bridge work will occur between Teague Avenue in Greenfield and Alta Street/Old Stage Road in Gonzales. Expect intermittent lane and ramp closures. Motorists can expect 20-minute delays.

The southbound Soledad State Prison on and off ramps will be closed from 8 p.m. Sunday to 7 a.m. Monday.

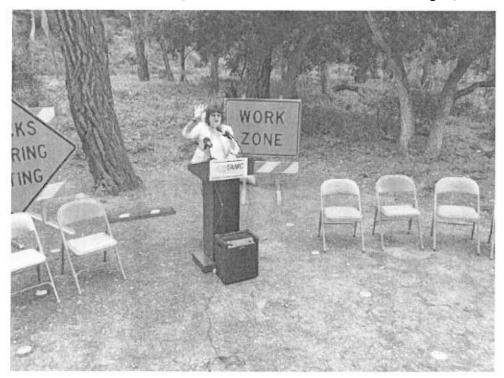

### Holman Highway roundabout breaks ground

#### CARMEL, Calif. -

Monterey County leaders gathered Monday morning in Carmel for a groundbreaking ceremony for the Holman Highway 68 roundabout project.

"I commute here every day and being able to cut through here is going to be fantastic," said commuter Mark Lotz.

Not everyone is happy about the roundabout, though. Some people we interviewed earlier in the year said they were dreading it.

"Horrible idea, because we've seen a few little roundabouts in the neighborhoods and nobody even knows what to do with the roundabout," said commuter Megan Maron during an interview in May.

Whether you are for the roundabout or against it, construction is set to begin on Wednesday.

The roundabout is going in at the point where Highway 68 and Highway 1 meet -- an area that typically sees bumper-to-bumper traffic.

At the groundbreaking event, project organizers and leaders spoke about the benefits of the roundabout.

"I think anyone who has ever been through this intersection at rush hour realizes it's not a good situation. We need a new approach. I really think this a great approach." said Pacific Grove Mayor Bill Kampe.

"From a safety, movement and environmental standpoint, it was the best," said Monterey Mayor Clyde Roberson.

During the construction period, which is estimated to be 10 to 11 months, there will likely be delays at night and in the early-morning hours.

"Give yourself 10-15 extra minutes at night," said Grant Leonard, with the transportation agency. "And by night work, we mean after 8 p.m. and before 6 a.m."

With the traffic delays in mind, project leaders are advising people to alter the way in which they commute.

Monterey-Salinas Transit is also offering deeply discounted monthly passes for those most affected. The project is costing more than \$8 million, but the funding is split between several cities and public organizations, with more than \$5 million in private money coming from the Pebble Beach Company.

"This improvement will be a great benefit to our residents, our visitors and the employees of the Pebble Beach Company," said David Stivers, with the Pebble Beach Company. "We are really proud to be a part of this whole project."

#### Road Report: Construction on Holman Highway roundabout kicks off

#### Officials laud project, which is expected to take a year

Carmel >> Construction of the long-awaited Holman Highway 68 Roundabout project kicked off Monday morning with a groundbreaking ceremony attended by local and county government officials along with representatives from both Community Hospital of the Monterey Peninsula, Pebble Beach Co. and other agencies that helped fund the \$10.5 million project.

And while no one is looking forward to the next five months or so of construction, said David Stivers, Pebble Beach Co. executive vice president and chief administrative officer, the benefits will outweigh any initial inconvenience.

The project, which is designed to relieve traffic congestion near the Holman Highway/Highway 1 intersection, is a public-private partnership between the cities of Monterey and Pacific Grove, the Pebble Beach Co., the Monterey Bay Unified Air Pollution Control District, Monterey County, Caltrans and the Transportation Agency for Monterey County.

Work was expected to begin in the spring, but organizers ultimately opted to wait until after Classic Car Week to begin construction. The project is expected to take about a year to complete.

"It's not often we get to set a model for the rest of the nation," said Monterey Mayor Clyde Roberson, from the podium outside the Unitarian Universalist Church of the Monterey Peninsula on Monday. Roberson noted that it couldn't have happened without a coordinated effort between multiple agencies. For its part, the city of Monterey contributed \$500,000 to the endeavor.

"None of the entities could have done it by themselves but by working together, we made it a solvent problem," said Roberson. The end result will be a safer intersection, less traffic and cleaner air, Roberson said.

"We usually don't think of it as such but it's a scenic and environmental project too because it's going to create less traffic and cleaner air," Roberson said.

David Frisbey of the Monterey Bay Unified Air Pollution Control District, which contributed \$350,000 to the project, also touted the environmental aspect.

"Roundabouts are about thinking differently. They reduce congestion and air pollution," said Frisbey. "In this instance, we'll reduce more than two tons in emissions."

Jim Cullen, a board member of Skyline Forest Association, also said the roundabout was the best solution.

"We knew increased traffic signals were not going to solve the problem," said Cullen, about the earlier planning stages.

Pacific Grove Mayor Bill Kampe said the project was important enough to the city of Pacific Grove for it to allocate \$100,000 in the city's regional surface transportation program funds toward it, despite the project not being within city limits.

"When it's done, you're really going to like the results," said Kampe.

The Pebble Beach Co. has invested \$4.8 million in the project. The Transportation Agency for Monterey County contributed \$3.6 million and Monterey County contributed \$68,000.

"We're very confident in TAMC and their outreach program and the construction," said Stivers, who credited the leadership of the city of Monterey's Rich Deal, the project's manager. "It will be a great benefit to our residents, visitors and employees of the Pebble Beach Co."

Monterey City Manager Mike McCarthy said the city will do its part to alleviate those potential traffic tie-ups, which are a concern for many Peninsula motorists.

"Our plan for the project has been to avoid significant impacts during heavier traffic times," said McCarthy. "There will be traffic impacts but our team is doing quite a lot to mitigate it."

McCarthy advised that residents and visitors check either the city's website (<u>monterey.org</u>) or the Monterey County Convention and Visitors Bureau's website (<u>seemonterey.com</u>) to stay abreast of traffic conditions during the project.

The Monterey Bay Aquarium is also lending its hand in that effort by stepping up its Tunnel Jumpers program, an expansion of its alternative transportation program designed to offer incentives to use alternative transportation like walking, biking and car pooling.

"As one of the main drivers of visitors to the Peninsula, we're anticipating great improvement for those who live and work here," said Barbara Meister, the Monterey Bay Aquarium's public affairs director.

Both McCarthy and Meister mentioned the partnership with the Monterey-Salinas Transit, which is selling discounted passes during the roundabout's construction and runs a trolley from downtown Monterey to Fisherman's Wharf and Cannery Row.

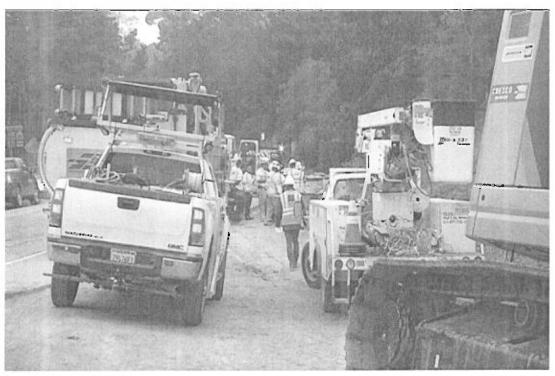

### **Construction begins on Holman Highway roundabout**

#### CARMEL, Calif. -

Construction on the Holman Highway 68 roundabout is underway. Crews will be working from 8 p.m. to 6 a.m. Wednesday and Thursday.

"Tonight, we are going to be doing some stripe removal, and then putting down some new strips. But the big thing, I think, is that we are going to put in a new signal in this intersection that will run temporarily throughout the project," said construction manager Bobby Pentorali.

Crews are taking out the traffic signals and replacing them with a roundabout. Pentorali says

there shouldn't be any major effect on traffic.

"There is going to be less protected turn movements, so there maybe a little bit of delay, a little bit of stacking up in the morning, in the afternoon, during busy times. But, generally speaking, there's not a whole lot that changes between now and, say, December or November," Pentorali said.

One thing will change before the end of the year.

"Come mid-September, all the way probably through November, December, you will have a different way to get through the intersection and get through 68," Pentorali said.

Before the complete makeover, commuters will also have to pay attention to minor changes.

"Coming off of Highway 68 now, it's going to be a left turn and straight through only. They don't have to wait for traffic on the other side," said Tom Fererra with St. Francis Electric.

For those still worried about construction delays, Monterey-Salinas Transit has dropped its monthly pass from \$95 to \$13 for those living, working and going to school in the area.

"That would be the west side of Monterey, as well as all of Pacific Grove, Carmel, Carmel Valley, down to Big Sur, and the unincorporated areas," said Hunter Harvath from Monterey-Salinas Transit.

MST hopes the discount will reduce traffic in the area.

"We are going to be fighting the congestion just like everyone else, so it really is important, not only to the community at large, but also to MST and our operations to get as many people off the road and out of their cars, and onto our buses," Havarth said.

These passes can be purchased at MST customer service centers in downtown Monterey, Maria, and downtown Salinas. A valid proof of residency is required. MST plans to offer discounted passes for as long as construction lasts.

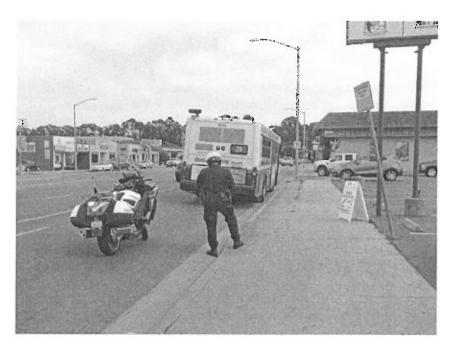
## Salinas police cites 47 drivers during 'pedestrian sting'

The sting was conducted between 12:30 p.m. and 5:30 p.m., first at the crosswalk located at Natividad Road and Sorrentini Drive and then at the crosswalk at North Main and Chaparral streets, according to Salinas police.

Plain-clothed officers walked back and forth across the street in the crosswalk while wearing a bright orange shirt as other officers in uniform and on marked police motorcycles or in a patrol unit waited nearby.

When a vehicle violated a pedestrian's right-of-way, the uniformed officers would stop the vehicle and cited the driver, according to police.

During the sting, citizens not involved in the operation would cross the street, and a vehicle violating their right-of-way would also be cited.

"Crossing the street was actually a bit frightening at times," said Sergeant Gerry Ross. "There were a few times that cars zoomed by me within three to five feet at 45 to 55 mph. Hopefully this sting operation will teach drivers to slow down and stop for pedestrians."

Salinas police chose these two crosswalk areas because of a history of vehicle/pedestrian traffic collisions at the locations, according to police. There has been a pedestrian killed at or near those crosswalks over the last few years.

In total, officers made 61 traffic stops and wrote 47 citations, nine of which were for cell phone use while driving. One citation was issued for a Monterey-Salinas Transit bus driver. Three of these drivers cited were also cited for driving while unlicensed, and another person was cited for allowing an unlicensed person to drive. One driver was arrested for an outstanding warrant.

Officers could have written even more tickets, but there were times that all the officers were busy writing tickets at the same time, according to police.

Funding for this program was provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.
